**Adjudicator** - Appointed as adjudicator in twenty construction adjudications.

**Solicitor** – Has represented parties in litigation, arbitration and adjudication.

<u>Arbitration</u> - Solicitor instructed as party representative in a variety of arbitrations related to construction and building, mostly for main contractors involving claims for prolongation, delay and disruption and for additional payment. Also instructed by private client as representative in claims for professional negligence. Appointed arbitrator for claims connected with water supply industry.
